# DUNEDIN NORTH INTERMEDIATE TUITION AGREEMENT, CONDITIONS AND TERMS OF ENROLMENT, and ACCEPTANCE FOR INTERNATIONAL STUDENTS

This is an agreement between the Dunedin North Intermediate School Board of Trustees and the applicant for tuition and delivery of the New Zealand Curriculum and it shall be signed on behalf of the International Student by a parent or legal guardian of the student.

'The School' refers to Dunedin North Intermediate.

'The Student' refers to the applicant.

The terms and conditions of enrolment and acceptance include the following:

- 1. All those terms and conditions expressly stated or implied in the Dunedin North Intermediate International Student Information Package.
- 2. The School shall provide tuition to the Student in accordance with the New Zealand Ministry of Education Code of Practice and the laws of New Zealand in return for an annual fee.
- 3. The Student shall comply with the rules and policies of the School and with the reasonable instructions from the teachers of the school.
- 4. The Parents or guardians of the Student ('the Parents') authorise the staff of the School to provide consents for school activities, travel outside the school and medical emergency where it is not reasonably practical to contact a parent.
- 5. The Parents authorise the staff of the school to relocate the child to alternative accommodation if their safety or well being is in any way compromised and where it is not reasonably practical or possible to contact the Parents.
- 6. The Parents agree to provide the School with academic, medical or other information related to the wellbeing of the Student.
- 7. The Parents give permission for any previous education provider to be contacted.
- 8. The School shall agree to use its best endeavours to ensure safety, health and wellbeing of the International Student. The School shall have no responsibility for the Student outside of school hours.
- The School will be responsible for providing tuition, and providing pastoral support in accordance with the Code, during the school term time which excluded the traditional New Zealand school holidays.
- 10. Under the Privacy Act, I understand that all personal information provided to the School is collected and will be held by the School.
- 11. The enrolment may be terminated if the Student:
  - Continually misbehaves and does not comply with the School Rules
  - Commits a criminal act or indulges in serious misconduct
  - Develops serious health (emotional or physical) concerns when it is considered the Student should return to the care of their parents
  - If the School can not provide for the Student's needs
- 12. It is acknowledged that all relevant provisions of the Education Act 1989 shall apply to the International Students in New Zealand. Any decision under these provisions to expel or suspend the Student for a specified period shall terminate this agreement and the refunds policy shall apply. The parents shall have no claim in damages or for any compensation if this agreement is terminated in these circumstances.
- 13. The School must be notified of any changes to accommodation, International Student status, or contact details.

- 14. If there are difficulties or problems that the Student or his/her family follow the Dunedin North Intermediate School Grievance Procedures as outlined in the International Student Information Package.
- 15. The School will not be liable for any loss or damage to property or persons, however caused except where such liability is imposed by New Zealand law.
- 16. Either party may terminate this agreement at any time upon two weeks written notice being given to the other party. If the agreement is terminated the refunds policy for International Students as outlined in the Refunds Policy shall apply.
- 17. Neither party is liable to the other for failing to meet its obligations under this agreement to the extent that the failure was caused by an act of God or any other circumstances beyond its reasonable control. The Refund Policy will apply.
- 18. This agreement shall be construed and take effect as a contract made in New Zealand and will be governed by New Zealand law, and the Student and Parents submit to the exclusive jurisdiction of the New Zealand Courts.
- 19. A school report from the Student's current overseas school must be provided to Dunedin North Intermediate School before the enrolment process is completed.
- 20. This agreement will be terminated if false information is provided by either party to the agreement.
- 21. The Student and/or family must officially request in writing any long term absence from attending school for a reason other than illness.
- 22. The school must be officially notified of the intention to withdraw from the contract, and it must be informed of the intended last day of attendance.
- 23. Notices given under this agreement must be in writing and given to the addresses set out in the application forms. Those sent by post shall be deemed to have been received five working days after posting.
- 24. This agreement contains all terms, representations and warranties made between the parties and supersedes all prior discussions and agreements covering the subject matter of this agreement.
- 25. The Student/Parents have the right under the Privacy Act 1993 to obtain access to and request corrections of any personal information held by the School concerning them.
